I have lived in cobar since I was a 10yr old.

I have seen the town build in my early time here. Lots of kids, lots of sports and lots of people participating in community events.

In more recent times I have seen the opposite. Less children in our schools, not enough people for the sports that used to be played and even less down along Marshall street on a Saturday morning.

There used to be 2 senior men's League teams, two senior men's Rugby teams and an men's AFL team. All contributing to and representing the town. Now we struggle to field one League team and one Union with no AFL. The social and economic benefit from this amount of participants has been completely lost. Potentially a contributing factor as to why we have such a high mental health development among middle aged men in Cobar.

The housing in town is available and affordable. Empty houses everywhere you look. If the mines aren't able to recruit in town it's from their own doing. By going FIFO and DIDO they inherently encourage families to leave. A Mum or Dad on a roster

Don't get to see their children often during their swing. By extending the roster for the mines own benefit. That mother or father can now base their family

Remote to town and offer them opportunities Cobar hadn't in the past. That was entirely each of the mines decision. Without that. There was no further need for the camp.

Encourage the purchase of local housing and community engagement. Because sitting out there on the hill having nothing to do with the town itself may be fine for the remote population, but goes nowhere in supporting Cobar itself.

The camp existence has been detrimental to date as it stands, let alone adding to its capacity. I personally would love to see the camp removed entirely!

We need to encourage people to live and work in Cobar if we want our town to survive... not allow drive a in drive out workforce... all jobs in Cobar should be residential only... if you can't live in our beautiful town you can't have a employment in it either

NSW needs to enact legislation similar to QLD's Strong & Sustainable Resource Communities Act to protect mining towns like Cobar who are suffering from mining personnels being accomodated outside of town on a FIFO and DIDO rosters and therefore do not spend any money in Cobar town itself. I love my town and don't want to see it turn into a ghost town
